AVONMOUTH DOCK

INTERRUPTION TO AVONMOUTH DOCK AVAILABILITY

NOTICE IS HEREBY GIVEN that works to install new outer flood gates in Avonmouth Lock will continue from the $15^{\text{th}} - 19^{\text{th}}$ April 2024 (inclusive).

These works necessitate the **CLOSURE** of Avonmouth Dock over the five **PM tides**; and a **RESTRICTION** of <u>no more than 140m LOA</u> for vessels <u>without tugs</u> or <u>130m LOA</u> for vessels <u>with tugs</u> over the **AM tides**, Mon-Fri 15th – 19th April 2024.

The first Avonmouth Lock closure will take effect from 0600 hours on 15th April 2024.

Avonmouth Lock/Dock will become available for shipping movements without the restrictions referred to in this Notice from 2330 hours on 19th April 2024.

Royal Portbury Dock will remain open and will be operating as usual throughout this period.
